



## The Imposter at the Rostrum?

Here is a man with the greatest power on Earth, who can order Air Force One to take him anywhere on the planet, who has spent the last two years transforming America — yet he will not reveal his birth certificate. What is he hiding? And why is the Congress of the United States willing to sit and listen to this man who may very well be the cleverest imposter who ever existed?

But no one in Congress or on the Supreme Court has ever seen Barack Obama’s original long-form birth certificate. Should he not have made it public when he sought the nomination for the presidency? compared to the fact that he stood before the lawmakers of America and refused to prove that he is a citizen of the United States by birth.
