Pelosi-Robespierre and the January 6 “Conspiracy”

Nancy Pelosi seems to be channeling Maximilien Robespierre these days. Pelosi insisted she wanted this to be a fair, bipartisan effort, but then exposed herself by rejecting Representatives Jim Jordan (R-Ohio) and Jim Banks (R-Ind.), two of the five GOP candidates nominated for the committee. Her peremptory rejection caused the Republicans to back out of what was to be an obvious sham. But the sham must go on, so Pelosi appointed Representatives Liz Cheney (R-Wy.) and Adam Kinzinger (R-Ill.), the two most notorious Trump-hating RINOs in the House, to give the committee a fig leaf of bipartisanship. Cheney is performing as expected, most recently reading out the nothingburger January 6 texts between Trump chief of staff Mark Meadows, Jim Jordan, Sean Hannity, and others as if they were smoking guns. Naturally, the prostitutes of the controlled media ate it up and regurgitated it endlessly. Appearing on MSNBC, the *Washington Post's* Jacqueline Alemany noted that "it is more powerful coming from a fellow Republican, Liz Cheney reading these messages out loud and putting her colleagues on notice."

The Pelosi-Cheney cabal had no reprimands or censures for January 6 Committee member Adam Schiff (D-Calif.) after he was caught having blatantly doctored a text message between Meadows and Jordan in his presentation to the committee.
