### Sweden Makes Plans to Deport 80,000

After being flooded with more than 160,000 refugees last year — an unprecedented number for the small Scandinavian nation — Sweden is already estimating that at least 80,000 asylum seekers' applications will be rejected. Then Sweden will have to figure out how to make them leave.

Whether or not Sweden can solve this problem will speak volumes about the risks of having open borders. According to Swedish Interior Minister Andres Ygeman, the mass deportations can be carried out, over several years, using specially chartered jets. It is hard to see any alternative (except perhaps using oceangoing vessels), but the logistics will be formidable. For one thing, where will they be flown to? There are no international airports or drop-off venues in Syria suited to the repatriation of refugees. Iraq is increasingly unstable outside of Baghdad. And the Taliban are rapidly reconquering Afghanistan.

Moreover, many refugees will physically resist rather than be deported willingly. Sweden may have to physically restrain deportees on flights, and reserve plenty of seats for security personnel to put down the inevitable in-flight rebellions.

The Swedish public is growing increasingly alarmed in the face of violent attacks and rising crime perpetrated by recent immigrants and refugees all across the country. The Sweden Democrats, a right-wing political party, has seen its popularity surge in recent months, thanks mostly to the Swedish government's steadfast refusal — until now — to acknowledge the severity of the immigration problem.

How and whether Sweden is able to put its plans into effect remains to be seen. But one inescapable lesson that Sweden — and the rest of Europe — is about to learn is that it is far easier to keep immigration under control in the first place than to do damage control after being overrun by a desperate and culturally disparate wave of immigrants, many of whom are willing to resort to crime and violence (and perhaps, in a few cases, even terrorism) rather than take orders from a host government in a country for whose culture and religion they have no respect.

### As Oil Price Drops, Iraq Faces Existential Threat

In Iraq, the culture of dependency is so great that the drop in the price of oil threatens the country's very existence. With every Iraqi dependent upon the government for essentials such as sugar, tea, rice, and cooking oil, and the government dependent upon oil for more than 90 percent of its budget, the existential threat is real.

In January 2015, the Iraqi government, headed up by President Fuad Masum and Prime Minister Haider al-Abadi, passed a budget that cut 16 percent from spending the year before. After assuming that oil would sell for \$56 a barrel and that it would export 3.3 million barrels of it every day, the government was still facing a deficit of almost 10 percent of the country's gross domestic product.

Other measures were employed: introducing a sales tax on airline tickets, vehicle sales, alcohol, and cigarettes. But oil prices dropped down into the \$40s, and the outdated and war-torn oil delivery system was only able to export an estimated two million barrels per day. So government payrolls were cut. As those cuts began to bite — some government workers and fighters battling ISIS (which controls one-third of the country) hadn't been paid in months — Iraqis took to the streets.

To stave off bankruptcy, Iraq began heart-to-heart conversations with Citigroup, Deutsche Bank, and JPMorgan for some short-term loans to cover the shortfall. In addition, the government is entreating the IMF to provide it with loans as well. And it is planning on selling some bonds backed by oil revenues.

Further cuts to government salary checks would likely tip the country into irreversible revolution. With unemployment at 25 percent, and 40 percent of those with jobs working for the government, the real issue is not dependency on oil, but on a government that is dependent on oil. The one permanent, seemingly eternal part of the budget that won't be cut is funding for the war against ISIS. Said Mudher Salih, a financial advisor to Abadi, "The priority is war. It's a matter of our existence."

## **Globalists Exploit Refugee Crisis for New World Order**

After having literally created the refugee crisis from start to finish — destroying multiple Middle Eastern nations and then demanding that Europe accept the millions of displaced victims — the internationalist establishment is now exploiting the chaos it unleashed to push more globalism and statism. ## **Clinton Set Up Hidden Network to Hide E-Mails**

Records recently disclosed by the Department of State as part of a Freedom of Information Act (FOIA) lawsuit reveal that Hillary Clinton — and senior officials within the State Department — acted to set up a hidden computer network to allow Clinton to access her private e-mail server without going through the secured — and archived — government network.

The revelation came to light February 1 when Judicial Watch made public the records received as the result of a court order in its FOIA lawsuit about the private e-mail server and account Clinton used

during her time as secretary of state. According to a release by Judicial Watch, the records included an e-mail thread detailing plans to “set up a stand-alone PC in the Secretary’s office, connected to the internet (but not through [the government] system) to enable her to check her emails from her desk.”

Over a two-day period right after Clinton was sworn in as secretary of state, several officials at the Department of State discussed the best ways to set up a computer so that she could check e-mail without having to access her private server over government channels.

Some familiar names appear in the “To,” “From,” and “Cc” fields in the e-mails: Huma Abedin is there, as well as Cheryl Mills. Other names include Patrick Kennedy, Lewis Lukens, and Daniel Smith.

The e-mail thread destroys any doubt that Hillary Clinton and her associates (perhaps accomplices would be a better word) were aware that they were keeping her e-mails “off the grid.” As Judicial Watch President Tom Fitton put it, “These emails are shocking. They show the Obama State Department’s plan to set up non-government computers and a computer network for Hillary Clinton to bypass the State Department network.” Furthermore, the State Department admitted to Judicial Watch that “Hillary Clinton was never issued secure State Department computing devices.”

Judicial Watch has accused Clinton of having “deliberately thwarted FOIA by creating, using, and concealing the ‘clintonemail.com’ record system for six years.” The e-mails seem to show that is precisely the case.

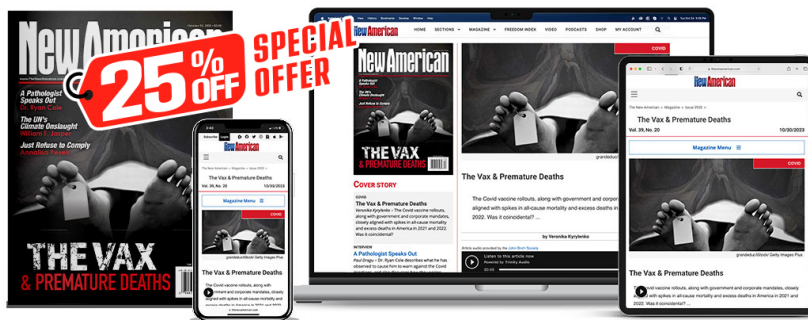
