Green Proselytizing

The April 17 TNA cover story “Green Religion” describes the current takeover of religious faith by the globalists. Especially shocking was the UN Ark of Hope, a mockery of the Ark of the Covenant. The Ark of Hope is a repository of environmentalist anti-God propaganda and plans for world control.

Whether you regard me or disregard me, doesn’t really matter to me. One way or the other. Your actions will determine your fate. Not mine. I am Nature. I will go on. I am prepared to evolve. Are you?

There are a number of these videos. Roberts’ video is titled *Mother Nature. Nature Is Speaking*. On YouTube alone, it now has been viewed by close to seven million people. Do they get the message that nature is more important than they are? What else could be understood by “I have *starved* species *greater* than you?”

Government Healthcare — Not

The series of articles written by Kurt Williamsen regarding healthcare (March 20 issue) addressed many points but did not mention the U.S. Constitution.

The first thing people should do when the federal government acts upon something is to look to the U.S. Constitution to determine if the action complies with or violates the U.S. Constitution. Whenever the federal government acts upon something, it is regulating something. Regulating healthcare is not an enumerated power expressly delegated to either the legislative branch in Article I or the executive branch in Article II.
