Study: Renewable Energy Not "Panacea" Climate Alarmists Claim

A study published September 16 by Irish and U.S.-based researchers is calling into question the efficacy of renewable energy sources such as wind and solar in dealing with the so-called climate crisis. In fact, the study found that such energy sources are extremely costly and may be causing as much climate change as they purport to mitigate.

Entitled *Energy and Climate Policy* — *An Evaluation of Global Climate Change Expenditure 2011-2018*, the study raises grave questions about the feasibility and cost of switching to an energy grid powered mainly by wind and solar farms. The study also points out several of the flaws of wind and solar energy, including the negative impacts they present on local environments.

Despite spending jaw-dropping amounts of money on wind and solar power globally since 2011, the study shows, climate alarmists and the nations that defer to them have definitely not gotten their money's worth.

The study's lead author, Coilin OhAiseadha, points out: "It cost the world \$2 trillion to increase the share of energy generated by solar and wind from half a percent to three percent, and it took eight years to do it. What would it cost to increase that to 100 percent? And how long would it take?"

At the same time the world was spending these ghastly amounts of money on green projects that have proven to be about as useful as a scuba diving suit in the desert, only five percent of global climate spending was used for adapting to extreme weather events and other alleged results of anthropogenic climate change.

Moreover, the study also found that wind and solar farms and other green energy schemes are contributing to the problem they were meant to solve, or otherwise damaging the environment.

"Ironically, given that these policies are being framed as environmentally desirable, many of the criticisms are with their environmental impacts. Many researchers are concerned about the negative







impacts that 'green energies' have on biodiversity," the study states.

Dictators Win Seats on UN "Human Rights Council"

Murderous and brutal dictatorships — including multiple mass-murdering communist and Islamist tyrannies — have been selected to serve on the controversial United Nations Human Rights Council. In the elections, held on Tuesday, October 13 at the dictator-dominated UN General Assembly, an array of corrupt and totalitarian regimes were elected or reelected by fellow governments to serve on the UN human rights body. Winners include the governments of China, Russia, Cuba, Uzbekistan, Pakistan, Nepal, the Ivory Coast, Malawi, Gabon, Senegal, Ukraine, Mexico, Britain, France, and Bolivia. The great majority of those governments are known as corrupt at best — and savagely oppressive at worst. Communist China is almost universally recognized as among the worst human-rights abusers on the planet.

"Today is a black day for human rights," complained UN Watch chief Hillel Neuer, whose Geneva-based nongovernmental organization monitors the UN and its actions on human rights. "Electing these dictatorships as UN judges on human rights is like making a gang of arsonists into the fire brigade.... It is an insult to their political prisoners and many other victims — and a defeat for the global cause of human rights — when the UN helps gross abusers act as champions and global judges of human rights. When the UN's highest human rights body becomes a case of the foxes guarding the henhouse, the world's victims suffer."

Fortunately for those who value sovereignty and reject UN hypocrisy and globalism, legislation to liberate the United States from the UN and all of its disgraced bureaucracies is already sitting in Congress. Under the American Sovereignty Restoration Act (H.R. 204), the U.S. government would cut all ties with the infamous "dictators club" while evicting its headquarters from American soil and ensuring that U.S. troops can never again serve under UN command.








2020 "Red Pill Expo" Exposes Federal Reserve, COVID Tyranny

America is being lied to by totalitarians and collectivists on a massive scale, to the point that liberty now hangs in the balance, declared experts in various fields and leaders from across America and beyond at the Red Pill Expo, which took place October 10-11. Montana Public Service Commissioner Randy Pinocci urged activists not just to complain on social media, but to become even more active by running for office in an effort to "become city hall," a regular theme at Red Pill Expos.

The 2020 Red Pill Expo smashed previous attendance records, despite mainstream media efforts to panic Americans into hiding at home and avoiding human interaction.

Group Says Critical Race Theory Needed to Fight Racism in







Math

In an October 2 statement, the Mathematical Association of America (MAA) criticized President Trump's decision to end the teaching of "critical race theory" within the federal government, asserting that math "inherently carries human biases."

"It is time for all members of our profession to acknowledge that mathematics is created by humans and therefore inherently carries human biases," the statement reads. "Until this occurs, our community and our students cannot reach full potential. Reaching this potential in mathematics relies upon the academy and higher education engaging in critical, challenging, sometimes uncomfortable conversations about the detrimental effects of race and racism on our community." "The time is now to move mathematics and education forward in pursuit of justice," MAA declares.

Further, the organization called critical race theory "an established social science inquiry which is grounded in decades of scholarship," and made the case that it is "misguided, at best, to reduce this theory to the race-blaming of white people and to define it and the discussion of systemic racism as a 'divisive concept.'"

The statement even argued that math and science are inherently political: "Although mathematics, science, and higher education develop fact-based theories and practices that should inform policy, they are also political because they exist within a highly politicized system. Acknowledging that the United States has serious systemic discrimination has somehow leaped from a political issue to a partisan issue."

Critical race theory is a social science framework that proposes that white supremacy is maintained over time through the law, and it looks at ways to free society from this alleged supremacy.

The MAA's argument that critical race theory is needed because mathematics is driven by "white supremacy" is not new. Leftists have gone so far as to state that the notion that 2+2 always equals 4 is based on white supremacy and that it can sometimes equal 5. The Left also says that things such as "objective thinking" and notions such as "hard work is the key to success" are signs of "whiteness."
