What They Said

*"I've spoken many times about my own family's refugee history. I will not join the chorus of people in this country or in this chamber who eagerly looked to slam shut an immigration door that was once open to our ancestors." — Illinois' Democratic Governor **J.B. Pritzker** delivered his State of the State address in February, asking the Legislature to approve \$182 million to help address Chicago's illegal-alien crisis.*

*"These are 2-, 3-, 4-, 5-year-old kids. They buy them for sex. Almost all the time, they get off on probation after buying a child and raping a little child. And we tried to say, well, they need to at least serve a minimum of 4 years. Democrats voted 100 percent that they did not want to put these pedophiles in jail." — Colorado state Representative **Scott Bottoms**, a Republican, aired his discouragement on social media in February after committee Democrats killed House Bill 1092, which would have mandated minimum sentencing for pedophiles. Bottoms ended with a plea for help. *"If you believe in prayer at all, please pray. We are fighting truly dark forces here."* He also asked for experts to step forward to testify.*

A "citizen journalist" for O'Keefe Media Group recorded a conversation with IRS criminal investigations officer **Alex Mena**.

He went on to say that the AI used to monitor private citizens is controlled by *"the Department of Justice and the Inspector General."*

The **Alabama Supreme Court** ruled in February that frozen embryos are children under state law, and that anyone who destroys them, willfully or accidentally, is liable under the state's 1872 Wrongful Death of a Minor Act.
