



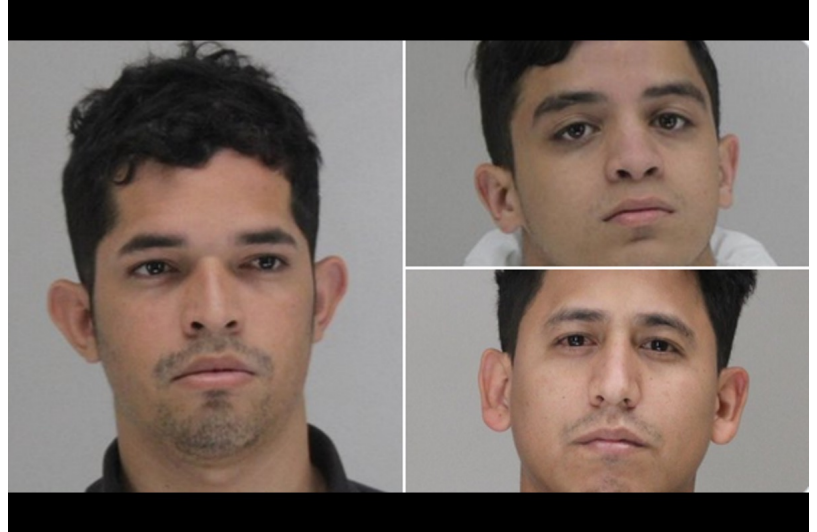

Three Biden “Migrants” Released at Border Charged With Capital Murder in Texas

Venezuelan “migrants” are President Joe Biden’s gift that keeps on killing.

The latest case of “migrants” freed at the border under the standing orders of Biden and his Homeland Security secretary, [unindicted visa fraudster](#) Alejandro Mayorkas, involves three Venezuelan hoods charged in the capital murder of a man at a Motel 6 near Dallas, Texas.

The Department of Homeland Security (DHS) has placed detainers on the newest members of a not-very-exclusive club: illegal-alien criminals who commit crimes — yet another murder in this case — enabled by the Biden administration.

The Murder

The Dallas Express reported that cops in Garland, about 16 miles northeast of Dallas, answered reports of a shooting at a Motel 6 at about 5:20 a.m. on June 20. There they found Santiago Lopez Morales, 48, who had been shot and was later pronounced dead at a hospital.

“The suspects, Yosguar Aponte Jimenez, 20, Jesus De Nazareth Bellorin-Guzman, 23, and Jose Luis Trivino-Cruz, 35, were arrested and charged with capital murder,” the [website reported](#):

Bellorin-Guzman also faces an aggravated robbery charge, while Trivino-Cruz is charged with aggravated robbery and indecent assault. Their bonds are set at \$1.5 million, \$2.25 million, and \$3.255 million, respectively, and all three are detained in the Dallas County Jail.

Dressed as a security guard and carrying a weapon, Morales showed up at the Motel 6 after a woman told him she was robbed there.

“Morales reportedly began messaging the suspects, posing as a prostitute online, to arrange a meeting” at the motel, the [website continued](#):

Surveillance footage detailed the incident: at 4:21 a.m., Morales’ pickup arrived, followed by

a Toyota sedan at 4:47 a.m. and a gray Acura at 4:54 a.m. At 5:07 a.m., one suspect exited the Toyota, approached room 137, and knocked. Morales, dressed as a security guard and armed, confronted the suspect, leading to a struggle.

A second suspect from the Acura shot Morales, who fell motionless. The three suspects fled in the Acura and Toyota.

Two men from the pickup threw rocks at the second suspect during the altercation, while two women later approached Morales' body, one seemingly calling 911.

A woman told cops that two Hispanic men robbed and sexually assaulted her at the nearby Deluxe Inn. They fled the scene in the Acura and Toyota. The woman fingered the murder suspects as the men who attacked from Motel 6 video footage.

"The suspects admitted to targeting sex workers, believing they were less likely to report crimes. Jimenez confessed to over 25 robberies, while Trivino-Cruz admitted to two additional robberies that day," the [website reported](#).

The three goons are charged with capital murder, the punishment for which is execution or life imprisonment.

Biden Released Them at the Border

[DHS confirmed](#) what one would suspect given that the suspects are Venezuelans, and that the Biden-Mayorkas Axis of Border Treason imported as many criminals as it could.

"Aponte-Jimenez crossed the southern border illegally on May 3, 2023, and was released into the U.S. by the Biden administration," DHS reported.

Trivino-Cruz illegally entered the country on October 9, courtesy of the insane Customs and Border Protection's CBP One smartphone application. It permitted would-be illegals to set up appointments for immediate release at the border. The app's purpose was to import as many "migrants" as possible and make deporting them as difficult as possible.

Likewise, Bellorin-Guzman illegally entered by the CBP One app on January 6. DHS turned the CBP One app into the CBP Home app [to expedite self-deportation](#).

DHS, again, has placed detainers on the three suspects.

So Biden and Mayorkas aided and abetted the entry into the country of three men who subsequently committed murder. Texas and American taxpayers will support them for the rest of their lives in prison if they aren't executed. That itself requires years of legal wrangling with far-left, pro-crime lawyers.

Other Victims

Another recent victim of the Biden-Mayorkas Venezuelan crime wave was Zach Carach. Police allege that Venezuelan illegal Tony Lopez Infante, driving a Mitsubishi Mirage, [mowed down](#) Carach at an intersection in Nashville, Tennessee. Carach was lucky to survive. The Biden Administration released Infante — who is still at large — into the country after he was caught at the border. Thus did a judge's final order of removal after an immigration hearing mean nothing.

Tony Gebian Lopez Infante, an illegal alien from Venezuela, is wanted for allegedly injuring

Air Force Academy Cadet Ava Moore [wasn't so lucky](#). The 18-year-old was kayaking on Lake Grapevine near Dallas on May 25 when Venezuelan illegal Daikerlyn Alejandraa Gonzalez-Gonzalez, 22, cops allege, plowed into her with a jet ski.

Arrested for felony manslaughter, Gonzalez-Gonzalez jumped the border in September 2023 — only to be promptly released.

Other victims of Biden's Venezuelan "migrants" are nursing student Laken Riley, 22, and Jocelyn Nungaray, 12.

Venezuelan Biden "migrant" Jose Ibarra murdered Riley. His attorneys [now claim](#) he was not mentally competent to stand trial.

Venezuelan Biden "migrants" Franklin Jose Pena Ramos and Johan Jose Martinez Rangel, prosecutors allege, [murdered Nungaray](#).

Neither Biden nor Mayorkas will be held responsible for the murders, rapes, and other crimes they knowingly aided and abetted by permitting thousands of unvetted illegals into the country.
