## Will Rittenhouse's Release on Bail Lead to More Left-wing Violence?

Kyle Rittenhouse, the teenager charged with homicide for shooting left-wing agitators in what he claims was self-defense while he was defending businesses from rioters in Kenosha, Wisconsin, was [released](#) Friday from law-enforcement custody after posting bail of \$2 million.

He was slapped with first-degree intentional homicide, first-degree reckless homicide, and attempted first-degree intentional homicide in relation to the deaths of Anthony Huber and Joseph Rosenbaum during riots in Kenosha sparked by the police shooting of Jacob Blake. Huber and Rosenbaum died from their wounds; a third man shot by Rittenhouse survived.

"Kyle Rittenhouse's bond was posted this afternoon at about 2:00 pm which was set up through his attorney," said Kenosha County Sheriff's Sergeant David Wright. "He is no longer in custody at the Kenosha County Jail."

Earlier this month, 19-year-old Dominick Black was arrested and charged with allegedly purchasing the AR-15 that Rittenhouse used.

Black is accused of receiving money from Rittenhouse and "then on May 1st he drove 300 miles north from Kenosha to a hardware store in upper Wisconsin to buy the [AR-15]," per an affidavit.

In October, Illinois did not press charges against Rittenhouse for possession of the AR-15 because the rifle was allegedly "purchased, stored, and used" out of the Prairie State.

Rittenhouse had some help in posting the bail that got him out of custody. Actor Ricky Schroder and My Pillow CEO Mike Lindell both contributed to the cause.

As the [New York Post](#) notes:

More than \$500,000 has been raised through a legal defense fund and through donations from high-profile supporters, WBBM said, including Lindell and Schroder, who first gained fame as a child actor in the 1979 classic "The Champ" — alongside Jon Voight — and TV's "Silver Spoons" in the 80s.

Meanwhile, Rittenhouse's release on bond didn't sit well with John Huber, whose son was killed by Rittenhouse.

"He has people out there who will help him, organizations, militia groups raising money for his defense right now," he said.

"He thinks he's above the law. He's been treated as such by law enforcement. He believes

he's justified in the case, and for him to run wouldn't surprise me."

Lin Wood, one of Rittenhouse's lawyers, posted a photo on Twitter celebrating his client's release on bail.

"FREE AT LAST!!!" Wood wrote on the post, which shows a Rittenhouse smiling between Schroder and attorney John Pierce.

Rittenhouse has understandably been demonized by the Left and the mainstream media, who have sought to sell a story that he attacked, unprovoked, innocent "peaceful protesters." For example, Rosenbaum was a sexual offender who raped five boys. According to [court records](#), he was imprisoned and made to register as a sex offender involved the molestation and rape of five separate boys between the ages of nine and 11.
