## Great Replacement Continues: 240K Illegals Stopped at Southwest Border, Biden-Mayorkas Release Almost 100K

<u>U.S. border agents "encountered"</u> almost 240,000 illegal aliens who tried to jump the border or showed up at ports of entry in May, a staggering, <u>record-breaking figure</u> that pushed the total for fiscal 2022 to more than 1.5 million.

With four months left in the fiscal year, which ends on September 30, the Biden administration has nearly equaled the 1.73 million illegals whom border agents caught or encountered in fiscal 2021.

As well, the latest filing in the *Texas v. Biden* case shows that Biden and his Homeland Security chief, <u>unindicted visa fraudster</u> Alejandro Mayorkas, released almost 100,000.

Thus does <u>The Great Replacement proceed</u> apace.


#### **Mostly Single Adults**

The vast majority of the 239,416-strong tsunami were single adults: 165,200, or 70 percent.

And though the number of illegals at ports of entry dipped 48 percent from 32,288 to 16,760, such was the increase in apprehensions of illegals who tried to jump the border — 9.6 percent — that total encounters jumped 1.7 percent.

So far this year, agents have encountered or apprehended 1,536,899, 88.6 percent of last year's 1,734,686.

If this year's pace continues, agents will encounter another 768,000 illegals by September 30. Total by then: 2.3 million.

As for releases, the data published in *Texas v. Biden* again showed just how determined Biden and his Cuban sidekick Mayorkas are to flood the country with impoverished migrants who will never be deported, even by a GOP president.

<u>CBP and Immigration and Customs Enforcement released</u> 95,318 illegals to disappear into the American heartland, a <u>decrease from</u> April's more than 117,000, but a shocking figure nonetheless.

Since the beginning of fiscal 2022 in October, Biden and Mayorkas have released 612,123 illegals to continue colonizing the heartland as part of The Great Replacement. Moving millions of Latin Americans into the country, along with Africans and others, is part of the Deep State's malevolent plan to dispossess and replace the American people with immigrants from the Third World.

Biden and Mayorkas have released 40 percent of the illegals encountered or apprehended.

If encounters continue at their present pace and Biden continues releasing 40 percent, some 920,000 illegals will have been released by September 30.

Biden <u>has released</u> more than one million since he took office.

American taxpayers will then foot the bill to feed, educate, house, and provide medical care for their replacements.

#### Traitor Mayorkas

Mayorkas, of course, has played a key role in replacing the people who built the country that took him in.

Caught finagling visas for rich foreigners, Mayorkas <u>has repeatedly said</u> he will not enforce black-letter immigration law, an impeachable offense.

As he told a gathering of the nation's mayors in January, "we will not dedicate our limited enforcement resources to apprehend individuals who have been here in this country for many years, who have been contributing members of our communities":

Unlawful presence in the United States will alone not be a basis for an immigration enforcement action but rather, we will allocate our efforts, we will allocate our resources on those individuals who present a current public safety threat, a threat to national security, or a threat to our border security, and that is a very important principle.

And we also want, with you, to champion our identity as a country. We want to champion our identity as a nation of immigrants: realize and harness and advance their contributions. That is who I think we are.
