Computer Repairman Sues Schiff, CNN, Daily Beast for Russian Disinfo Lie That Wrecked His Business

The Lawsuit

[Isaac filed suit](#) in the Montgomery County (Md.) Circuit Court on May 3.

After Biden dropped off the laptop at the store and didn’t reclaim it, Isaac gave it to federal agents and, again, Giuliani’s cutout. The rest is well known. The *Post* published an exposé that was immediately denounced as false. The laptop, the leftist media reported, was Russian disinformation. That was the lie [repeated by](#) more than 51 U.S. intelligence officials and every other Biden partisan in the media until the [New York Times fessed up](#) weeks ago. The laptop and its explosive emails — which revealed the workings of the Biden Mafia — are, indeed, authentic.

Unhappily, the *Post* “published a photo of the Repair Authorization without blurring the business name thereby notifying the public and the media where BIDEN had dropped off his laptop,” the lawsuit says.

Thus did an army of leftist media operatives invade Isaac’s shop, and the 51 “intelligence” officials declare the laptop “Russian disinformation.”

Schiff and the leftist media quickly ran with the lie.

Schiff appeared on Wolf Blitzer’s aged CNN program *Situation Room*. “Does it surprise you at all that this information Rudy Giuliani is peddling very well could be connected to some sort of Russian Government disinformation campaign?” Blitzer asked.

Well we know that this whole smear on Joe Biden comes from the Kremlin. That's been clear for well over a year now that they've been pushing this false narrative about the vice president and his son. The lawsuit also notes that President Trump's former intelligence chief, John Ratcliffe, refuted Schiff's ridiculous claim the next day. "We have shared no intelligence with Chairman Schiff, or any member of Congress, that Hunter Biden's laptop is part of some Russian disinformation campaign," [Ratcliffe told](#) Fox News' Maria Bartiromo.

Isaac lost his business, the lawsuit says, because Schiff's "false and defamatory campaign statements accuse the Plaintiff of committing an infamous crime, i.e., treason by working with the Russians to commit a crime against the United States of America by attempting to undermine American democracy and the 2020 presidential election."

As for CNN, it broadcast Schiff's lies with malice and reckless disregard for the truth because the hate-Trump, pro-Biden network "had actual knowledge of the falsity of the claims."

[The Daily Beast published](#) a piece that discussed the "the purloined laptop," a lie that, the lawsuit alleges, it refuses to correct. It compounded that lie with another, in a headline that called the laptop "stolen." And as did CNN, The Daily Beast strongly suggested that Isaac passed along "Russian disinformation."

CNN and the Beast, too, the lawsuit alleges, are responsible for destroying Isaac's business.

Media Blew It

The media's suppression of the laptop story will go down as one of the most obvious cases of shilling for a presidential candidate since a whole four years ago, when they went to bat for Hillary Clinton.

And clear from the beginning was the media's reason [to suppress](#) the story. Forget the scandalous photos of Hunter Biden in various stages of undress. Or his sniffing cocaine off a woman's behind. The laptop's emails disclosed details of the [Biden-Burisma influence-peddling](#) scheme, as well as [Joe Biden's 10-percent cut](#) of the profits from Hunter Biden's business venture with Chinese Reds.
