Sydney Powell: Trump got “at Least 80 Million Votes”

In an [extraordinary interview](#) at Newsmax on Tuesday, Sidney Powell, a lead attorney in the Trump campaign to expose the election fraud, told Greg Kelly:

The will of the people was for Trump to win in a landslide. And if we can get to the bottom of it, and I am determined to do that, I think we will find that he had at least 80 million votes.

The only reason the glitches happened in the system was that he was so, had so far many more votes than they calculated in advance. Their algorithms could not perform the functions that they had originally performed that were set to perform.

They couldn't make up the vote count. He had gotten so many hundreds of thousands more votes than they planned.

So that's when they had to stop the counting and come up with a way to backfill votes or destroy votes for Trump while they created votes for Biden.

She added: “We’re fixing to overturn the results of the election in multiple states ... President Trump won by not just hundreds of thousands of votes but by millions of votes.”

How does she know? She answered, “We have sworn witness testimony of why the software was designed. It was designed to rig elections. [One witness] was fully briefed on it. He saw it happen in other countries. It was exported internationally for profit by people [who] are behind Smartmatic and Dominion. They did this on purpose ... we have so much evidence I feel like it's coming in through a fire hose.”

She said “Dominion has a long history of rigging elections. That's what it was created to do to begin with.” She told about her whistleblower, a former high-ranking Venezuelan military officer who worked with the former communist Venezuelan dictator Hugo Chavez. He told her that “it was created ... so Hugo Chavez would never lose another election, and he did not after that software was created. He won every single election.”

The program was exported “to Argentina and other countries in South America,” she said, “and then they brought it here.”

In another [interview](#), Lin Wood, the powerhouse attorney who successfully represented Richard Jewell, the so-called Atlanta bomber, and teenager Nick Sandmann, after reviewing the evidence Powell and lead attorney Rudy Giuliani had accumulated, concluded:

This election was a fraud. Donald Trump won, I believe, clearly a 70 percent-plus landslide election ... he probably won over 400 Electoral votes....

America is going to learn the truth soon that Donald Trump won an overwhelming landslide, probably historic victory. That’s what everybody in the country felt. That’s what the voters have felt. That’s why you got ninety-six mile caravans in Arizona. That’s why you’ve had millions go to rallies.

It also might explain why Biden didn’t bother to campaign. He thought he had it in the bag, so why bother?
